

2022 MI HOSA State Leadership Conference In-Person Competition Event Breakdown MRC Partnership



Congratulations on qualifying for the Michigan HOSA State Leadership Conference!

Timeline:

- **January 15:** Conference Registration Deadline
- **February 24th or 25th:** Presentation given to Judges (conference schedule will be posted on the [SLC Info Page](#) closer to conference date)

Event Breakdown: (based off [National HOSA guidelines](#))

- **Competitor's MUST present a photo ID or proof of identity when checking in to their competitive event.** A clear picture of a photo ID is acceptable. If a student does not bring a photo ID, the student's advisor may be asked to report to the event manager or HOSA Headquarters and verify the student's identity.
- **There is NO TALLO upload requirement for this event at the state level.**
- At the conference, please report to the room at the time listed in the conference program (available at the conference). Event manager(s) will check competitors in. Depending on the number of participants and sections, event managers may give competitors an appointment time to come back instead of waiting by the room.
- The event manager will introduce the competitor to judges. Please do not shake judges hands to help prevent the spread of germs. Competitors can politely say "hello" then begin setting up for their presentation.
- Per the event guidelines, competitors will have a total of five (5) minutes to interview with the judges. The first three (3) minutes will be reserved for prepared remarks by team members. Following the prepared remarks, two (2) minutes will be provided for judges to ask questions. More information can be found on page 4-5 of the MRC Partnership Event Guidelines.
- After the interview, teams will be dismissed from the room while judges have three (3) minutes to rate and review portfolios. We ask that teams stay outside the room and wait to collect their portfolio after the judges have finished. If instructed otherwise, portfolios will be available for pickup at HOSA Headquarters following the completion of the event.
- A timekeeper will not be provided for this event. Judges have been instructed to inform competitors of the time(s) remaining.
- Judges will use the Rating Sheet provided in the MRC Partnership event guidelines (www.hosa.org/guidelines).

- Judges are instructed NOT to talk to students after presentations. Competitor rubrics are confidential and will not be shared with students after competition. Any feedback judges wish to give students will be written on a “Judge Feedback Card” and given to the HOSA advisor following the Grand Awards Ceremony on Friday the 25th.
- Absolutely NO spectators are not allowed to watch presentations. The only authorized personnel in the competitive event room are judges, event manager(s), HOSA staff and the competitor/team.

Dress Code:

As Future Health Professionals, HOSA members should present themselves in a professional manner. Competitors shall wear official HOSA uniform or proper business attire for judge presentations. Bonus points will NOT be awarded, but event managers will make note if competitors are NOT in proper dress which could result in overall point deduction.
