## Timeline:

- January 15: Conference Registration Deadline
- February 24th or 25th: Presentation given to Judges (conference schedule will be posted on the <u>SLC Info Page</u> closer to conference date)

### Event Breakdown: (based off National HOSA guidelines)

- Competitor's MUST present a photo ID or proof of identity when checking in to their competitive event. A clear picture of a photo ID is acceptable. If a student does not bring a photo ID, the student's advisor may be asked to report to the event manager or HOSA Headquarters and verify the student's identity.
- There is NO TALLO upload requirement for this event at the state level. Please bring your completed portfolio and skill video to your judge presentation.
- At the conference, please report to the room at the time listed in the conference program (available at the conference). Event manager(s) will check competitors in. Depending on the number of participants and sections, event managers may give competitors an appointment time to come back instead of waiting by the room.
- The event manager will introduce the competitor to judges. Please do not shake judges hands to help prevent the spread of germs.
- Per the event guidelines, the presentation given to the judges including the skill video review will be six (6) minutes. After the presentation, competitors will be excused and judges will review portfolios and complete competitor rating sheets. Please wait outside the room to receive your portfolio, unless the event manager says otherwise. If portfolios are not given back to students after the presentation, they will be available for pickup in HOSA Headquarters once the event is over.
- Competitors will have a total of six (6) minutes to present to judges.
- A timekeeper will not be provided for this event. Judges have been instructed to inform competitors when there is one (1) minute remaining and will stop the presentation after six (6) minutes.
- Judges will use the Rating Sheet provided in the Clinical Specialty event guidelines (www.hosa.org/guidelines).

- Judges are instructed NOT to talk to students after presentations. Competitor rubrics are
  confidential and will not be shared with students after competition. Any feedback judges
  wish to give students will be written on a "Judge Feedback Card" and given to the HOSA
  advisor following the Grand Awards Ceremony on Friday the 25th.
- Absolutely NO spectators are not allowed to watch presentations. The only authorized personnel in the competitive event room are judges, event manager(s), HOSA staff and the competitor/team.

## **Dress Code:**

As Future Health Professionals, HOSA members should present themselves in a professional manner. Competitors shall wear official HOSA uniform or proper business attire for judge presentations. Bonus points will NOT be awarded, but event managers will make note if competitors are NOT in proper dress which could result in overall point deduction.
